## Content

The programme will focus on various frameworks of strategic planning of IT roadmaps for organisations and will discuss issues related to management of IT projects and proper execution of the same. The programme will also emphasise various facets of IT project justification starting from various financial models to benefits management. A few topics which the programme will focus on are as follows:

- Aligning IT with business strategy
- Identifying information requirements of managers
- Managing outsourcing
- Managing employees and performance: The people framework
- Concept of strategy: Corporate and competitive
- Tracking organisational performance – BSC and strategy formulation and implementation

- Developing an IT applications portfolio
- Business intelligence
- Governance and structuring of IT organisations
- Managerial evaluation of projects

## Methodology

The lead learning tool will be case studies which will be supplemented by lectures, group presentations, group exercises and games along with self learning. To integrate the learning, the programme will end with an integrated case or a practical problem-based group presentation.



## Nominations and Inquiries

## Venue and Accommodation

## Discount

**Early Bird Discount:** Nominations received with payments on or before **November 07, 2016** will be entitled to an early bird discount of 7%. Early submission of fee and nomination does not however guarantee acceptance of the application.

**Group Discount:** Any organisation sponsoring four or more participants will be entitled to a discount of 7% on the total fee payable provided that at least four participants actually attend the programme. Organisations can avail themselves of both the discounts subject to a maximum overall discount of 10%.

Any organisation sponsoring 25 or more participants across all the programmes in one academic year will be entitled to an overall discount of 15% on the programme fee payable.

The above discounts will be applicable only when the requisite numbers of participants actually attend the programmes.



## Alumni Association

Participants who are attending short-duration Executive Education Programmes for the first time on or after April 1, 2012, will have to attend for a total of 21 days in one or more programmes in order to be eligible for alumni status and the alumni identity card, both of which will be awarded on the payment of a one-time alumni fee of INR 10,000.
