

Two-week Chief Information Officer Training Programme, CB Phase II

at IIM Ahmedabad and London, UK November 14-28, 2016

e-Governance is being seen as one of the important tools for Governance reform. India had launched a National e-Governance Programme (NeGP) in 2006 with a large outlay for expanding e-services for citizens and businesses. More recently Digital India Programme has been launched to significantly enhance connection up to village level and further strengthening of e-Governance. NeGP is being implemented in a public-private-partnership mode. Programme managers have laid significant emphasis on capacity building.

IIMA has been a pioneer in the field of e-Governance in India. The Centre for e-Governance (CEG) was set up at the Indian Institute of Management Ahmedabad (IIMA) in October 1999 with the objective of p romoting the practice of e-Governance in India through research, consultancy and capacity building. Faculty from the CEG have carried out a large number of Impact Assessment Studies funded by the World B ank and Department of IT, Government of India. Amongst others, the CEG has also conducted a number of 8-12 week residential Programmes on Planning and Implementation of Information Systems for e-Governance for the Government of Andhra Pradesh.

NeGD, in partnership with IIMA is involved in the delivery of a two week Programme - Chief Information Officers' (CIOs') Training Programme - to be delivered f or senior level government functionaries to build the knowledge and skills of selected officers who are leading, managing and implementing e-Governance M ission Mode Projects (MMPs) under NeGP and other e-Governance projects in the Central Ministries/ Departments or States/UTs. The broad contours of the Programme are given below.

Programme Objectives

The Programme is intended to provide an understanding of the entire life cycle of an e-Governance project so as to prepare the participants to play a leadership role in conceptualizing and implementing e-Governance projects in Government agencies through a PPP model. The objectives of the Programme are to:

• Highlight the potential role of ICT in improving the process of delivering government services and quality of governance to different stakeholders.

- Provide a framework for choosing an application portfolio which aligns the potential benefits from e-Governance applications to the purpose and objectives of a Government agency.
- Provide an overview of tasks involved in conceptualizing designing and implementing e-Governance applications.
- Provide an understanding of the critical success factors in implementing e-Governance applications through PPP at a project and country level.
- Expose the participants to the technology infrastructure available to build e-Governance applications and the process of evaluating technology architecture.
- Expose the participants to international practices in e-Governance implementation which are relevant to the Indian context.

Programme Structure, Content and Pedagogy

The Programme will be conducted in three modules. The first module will be conducted over 4 days at IIMA. Class sessions would be conducted in a discussion mode on topics relevant to achieving the above objectives. The sessions would consist of presentation by the faculty, case discussions lead by the faculty and group work and presentation by the participants. Participants will be provided conceptual papers, case studies as back ground reading in preparation for the class discussion. Participants will be required to put in 2-3 hours of work every day after the class sessions to prepare for the next day's classes.

The second Module will consist of a one week study tour in UK. The objective of the study tour is to expose the participants to international practices in e-Governance implementation which are relevant to the Indian context. The study tour will consist of organized meetings with senior functionaries of e-Governance project teams. Typically the functionaries will make a presentation about the broad details of project and the manner in which it was implemented. Perspective of private service providers through selected case studies and presentations from them will also be provided. In follow up discussions, the participants will have an opportunity to seek clarification and information on issues of interest to them.

The third module will be conducted as a workshop for one day after the participants return from their study tour. This will include debriefing session where participants will present the learning from their study tour and IIMA faculty will wrap up the learning from the entire Programme.

Nearly 25 session of 75 minute duration will be conducted in modules one and three over six days. The topics covered will include:

- Understanding the Evolution of e-Governance in the Indian and Global Context
- Developing a strategic perspective on E-Governance
- An assessment of the National e-Governance Plan (NeGP) and Digital India Initiative in terms of impact on the stake holders. Review of the current Technology infrastructure for e-Governance
- Life Cycle of an e-Government Project: Issues in Developing DPR, RFP, Master Contracts
- Government Process Reengineering (GPR)
- Critical Success Factors in implementing e-Governance
- Business models and Public Private Partnership for e-Governance Project
- Managing a e-Governance project from conceptualization to implementation
- Project Management
- Change Management and Capacity Building for e-Governance
- Challenges in expanding e-Service Delivery to Rural Areas, UID as a game changer in e-Delivery of services
- Citizen Engagement using social media
- Information Security Management, issues of privacy of data
- Technology architecture for e-Governance -Enterprise Applications and Open Source for e-Governance
- Regulatory framework for e-Governance (IT Act and Contract Management)

Programme Fee

The Programme fee for the selected participants will be paid by the NeGD directly to IIMA. The fee will cover expenses for boarding and lodging in Ahmedabad for 6 days and boarding and lodging in London for 6 days. Travel expenses for Ahmedabad to London and local transportation in Ahmedabad and London relating to academic content will also be covered.

Sponsoring organizations will have to arrange for travel to Ahmedabad and any fee associated with obtaining a UK Visa. Participants will need to obtain a UK visa prior to coming to Ahmedabad. They will be provided the necessary documents to indicate that travel is a part of training Programme sponsored by DeiTy Government of India.

Venue and Accommodation

The programme will be held at the Indian Institute of Management, Ahmedabad. Participants would get a full board and air-conditioned single room accommodation on the Institute campus for Modules 1 and 3.

IIMA norms do not allow participants to have guests stay with them during the programme.
